Blue Spring State Park - Encounter the Gentle Giants we call Manatees.

Hundreds of manatees make this park their home for the winter, and viewing these gentle giants from the spring's overlooks is a rare experience. The refreshing 72-degree waters of Blue Spring State Park greet visitors at this gem along the St. Johns River. By 2005, after years of park improvements and manatee protection efforts, wintering manatee numbers exceeded 200, and by 2022 that number skyrocketed to a record 724.
